

RESOLUTION NO. 2026-05-13

A RESOLUTION OF WALLA WALLA FIRE PROTECTION DISTRICT NO. 7 AUTHORIZING THE TRANSFER OF ALL REAL PROPERTY AND REAL PROPERTY INTERESTS TO WALLA WALLA NORTH COUNTY FIRE DISTRICT

WHEREAS, the voters within the service area approved the formation of the Walla Walla North County Fire District as a Rural Fire Authority pursuant to the laws of the State of Washington; and

WHEREAS, the Board of Commissioners of Walla Walla Fire Protection District No. 7 finds that the transfer of all real property and associated interests owned by the District to Walla Walla North County Fire District is necessary and appropriate to ensure continuity of fire protection, emergency medical services, and related operations; and

WHEREAS, the transfer of such property is in the best interests of the public and will allow all land, buildings, stations, improvements, easements, and associated real property rights to be held and administered by the newly formed Rural Fire Authority; and

WHEREAS, the Board desires to authorize and direct the transfer of all real property assets and interests of the District to Walla Walla North County Fire District effective upon completion of the necessary legal documentation and recording requirements;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF WALLA WALLA FIRE PROTECTION DISTRICT NO. 7 AS FOLLOWS:

SECTION 1. AUTHORIZATION OF TRANSFER

The Board of Commissioners hereby authorizes the transfer, conveyance, and assignment of all real property and real property interests owned by Walla Walla Fire Protection District No. 7 to Walla Walla North County Fire District.

SECTION 2. PROPERTY INCLUDED

The transfer shall include all real estate, fire stations, buildings, structures, improvements, easements, rights-of-way, parcels, and any other interests in real property currently held by the District.

SECTION 3. AUTHORITY TO EXECUTE DOCUMENTS

The Fire Chief, Board Chair, Secretary, and/or their designees are hereby authorized and directed to execute all deeds, conveyance documents, assignments, affidavits, and any other instruments necessary to complete and record the transfer of said property to Walla Walla North County Fire District.

SECTION 4. CONTINUITY OF OPERATIONS

The Board finds that the transfer authorized herein is necessary to ensure the continued operation and administration of fire protection and emergency medical services under the authority of the newly approved Rural Fire Authority.


SECTION 5. EFFECTIVE DATE

This Resolution shall take effect immediately upon its adoption.
